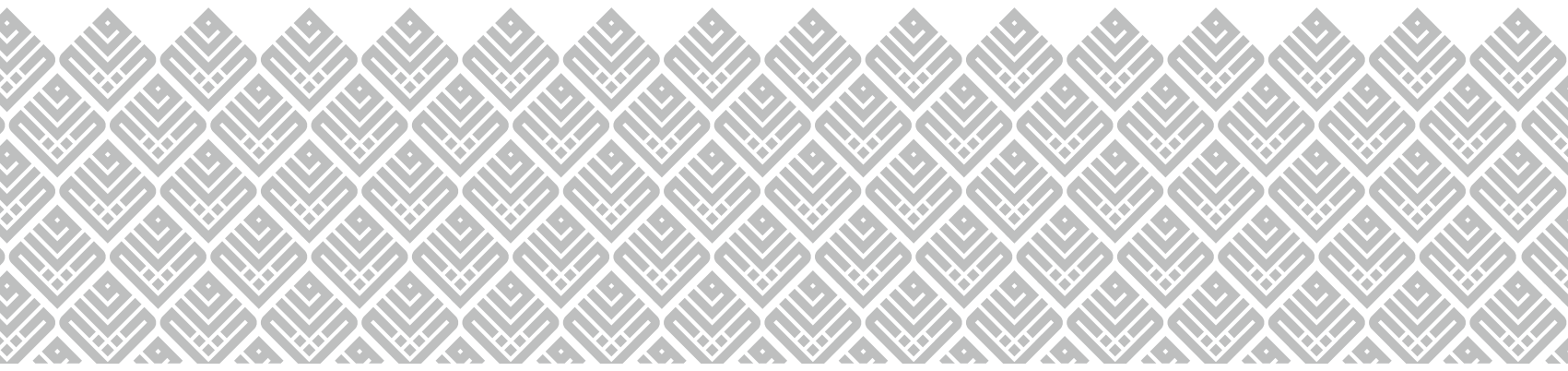




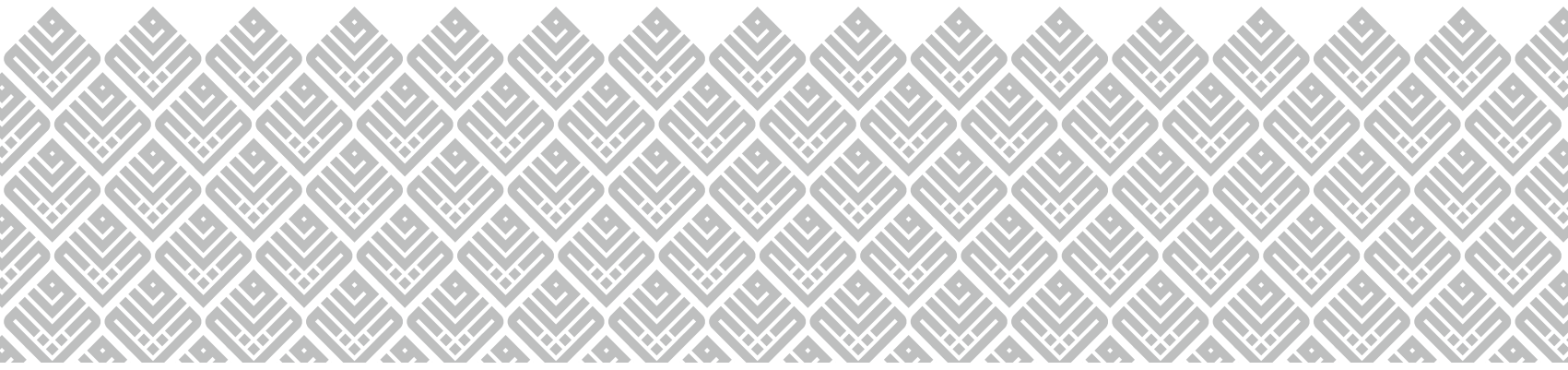

Legal Services

We are pleased to offer you some of our legal services, which include but not limited to the following main areas:

Consultation:

Our Firm provides legal consultation services in all legal aspects, whether commercial, criminal, administrative, labor or others for individuals and organizations. Our Firm also studies corporate international status and provides consultation in the relationship with others. We can attend meetings with the company or establishment owner or representative as well as participating in the decision making if we are asked to.

Review, drafting and scrutiny:

Our Firm drafts, reviews and scrutinizes all types of contracts and agreements according to the laws applicable in the Kingdom of Saudi Arabia. We also draft memoranda of understanding (MOU), legal letters, reply letter addressed from or to your side, review regulations and legal documents, prepare bylaws, policies and the organizational structure of the entity.

Representing our clients before various authorities and bodies:

Our Firm represents our clients before all courts of various levels and specializations, judicial authorities, commissions, and quasi-judicial panels. We prepare and submit statements, memos, plea, appeals and briefs before judicial bodies and committees, follow up case proceedings up to the final ruling and complete execution procedures. Our Firm also represents our clients before all government institutions and authorities including pleading in all type of cases of all issues in which we represent our clients. We also furnish our clients with detailed procedural reports about each session or follow up explaining the work we are performing and the measures required to be taken.





Legal Services

Other legal works:

Our Firm provides numerous other legal works including but not limited to the following: corporate establishment and relevant amendments, whether with regard to a partner entry or exist, partners' decisions, registration of trademarks and trade names, franchise contracts, electronic commercial contracts (e-commerce); representation of clients, whether individuals or establishments, in claiming or collection of their rights, such as collection of debts from others. We can also study all problems which they may face in terms of legal aspects and provide consultation and legal advice, in order to take the suitable relevant decision in addition to our participation in different negotiations and meetings whenever we are requested to that end.

Notarization Activities:

Our Firm notarizes the contacts and declarations, pursuant to Article Two of the Notary Public Regulation, covering the following:

Sale and documentation of real estates, conclusion, amendment and release of mortgages and pledges, distribution of movable money, conclusion and cancellation of agencies, lease contracts, corporate contracts, amendment annexes and stakeholders' decisions, bail for appearance declaration, penalty bail or release thereof, debts declaration, delivery and assignment, trademarks actions, patents, copyright and movable money contracts.



Legal Services

Distribution of estates:

Our Firm is keen to apply our own special criteria prior to the distribution of the estate which are: sorting wills and endowments from the legacy prior to distribution, mortgaged real estates, legacy debts etc., repayment of legacy assets, debts, evaluation of the estate elements by specialists, distribution of legacy assets between the beneficiaries by means of agreement or through the court; transfer of ownership of the shares sorted to the beneficiaries in addition to company liquidation, settlement of legal status, and asset evaluation and distribution.

Endowments and Wills:

We assist our clients in drafting the will or the deed of endowment and notarization thereof before courts as valid documents against others and protection against loss. We conduct legal supervision and care of endowments while managing and investing their money and dispose of its returns within endowment condition limits in order to accomplish Sharia purposes; and provide a number of suggestions in charity outlets and investment activities of the endowment.





Legal Services

Registration of trademarks:

Trademark: is the mark which distinguishes a product from other similar products and through which the quality of such product becomes clear. Therefore, the owner of such marks are keen to register them at the Ministry of Commerce and Investment in order to make their products stand alone for fear of imitation. Thus, our Firm undertakes, on behalf of the owners of such marks, whether individual or an establishment- the registration of the trademarks without the need to refer to the Ministry of Commerce and Investment. Our Firm also takes all measurements in order to protect such trademarks and prevents counterfeiting.

Intellectual Rights:

Our Firm undertakes all procedures concerning protection of intellectual rights such as: copyrights and patents and takes all ensuing litigations in this regard.





Litigations

Administrative Litigations:

Administrative litigations are among the most important issues concerning the administrative law where our Firm conduct study analysis of litigations and bring them before the administrative judiciary. Among such cases, which our Firm handles: (cases of revocation of administrative decisions, compensation or job rights litigations such as: allowances etc. and all litigations concerning administrative contracts). We also provide legal consultation to our clients prior to signing of such administrative contracts and direct our clients to take the right decision during the state of confusion between raising a revocation lawsuit or a compensation lawsuit.

Enforcement litigations:

Our Firm undertakes enforcement of judgments, decisions and orders issued by courts, and awards of arbitrators appended with execution writ according to the Law of Arbitration, reconciliation minutes issued by competent authorities or ratified by the courts, commercial documents, judicial orders, documented releases issued in a foreign country, ordinary documents which content is recognized in part or in whole, other contract and documents which have the supporting execution writs as per the Law.

Banking litigations:

Our Firm undertakes the study and representation of our clients in all banking cases resulting between the banks and our clients. Among such cases are finance and lending cases etc. We can also file pleading and provide legal consultation in this regard.

Litigations before general judiciary including:

General Courts:

Our Firm undertakes all lawsuits, final registrations and property related cases in terms of ownership litigation, related right, damage lawsuit against the same property, its beneficiaries, lawsuit of acquiring interests, documentation, payment of charge, or contribution in the same or a lawsuit for attempt to possess or reclaim the same etc.; issuance of property ownership deeds, its endowment, and lawsuits arising from traffic accidents and violations stipulated in the traffic regulation and its implementation regulation; and all financial claims.



Courts

Commercial courts:

Our Firm undertakes all original and consequential commercial litigations which occur between traders, cases filed against the trader due to original or consequential commercial works, conflicts occurring between corporate partners, all commercial regulations cases and violations, bankruptcy lawsuits and placing bankrupts under guardianship and lifting the guardianship and other commercial disputes.



Courts

Criminal courts:

Our Firm undertakes all criminal cases and appears before all circuits including penal circuits, Qisas (retribution) and Hidood (fixed punishments) cases penal and juvenile cases circuits.

Labor courts:

Our Firm undertakes all cases concerning labor contracts, wages, rights and labor injuries and compensations, litigations against the employer, worker punitive punishments or relief of the same, lawsuit filed to impose punishments specified in the labor law, litigations of dismissal from work, employers complaints, and employees whose pleadings were not accepted against any decision issued by any specialized organ in GOSI (General organization for social insurance) issues concerning the necessity of the registration and subscriptions or compensations, litigations concerning workers subject to the Labor Law provisions including government workers, litigations resulting from application of Labor Law and Social Insurance Law.



Personal affairs courts:

Our Firm undertakes all personal affairs issues including: registration of marriage, divorce, marriage revocation, remarriage, custody, alimony, visit, registration of endowment, will, kinship, alibi, death, estate registration, heritage, distribution of legacy- including property- in case of conflict or endowment share, will, juvenile, absence, registration of custodians appointment, cases of establishing guardians and receivers, request permission for them for actions requiring court permission; request their ouster during litigation, request to isolate irresponsible, cases resulting from personal affairs, and cases raised to impose penalties stipulated in the general committee placing custody on the juvenile money and in their alike.



Companies

Companies:

Our Firm undertakes the establishment of companies - national or foreign - and takes all procedures for establishing the company, starting with drafting the articles of incorporation, publishing it, and documenting it with the official authorities. Even obtaining a commercial register for the company.

Wathyq also undertakes all procedures related to companies after their incorporation, such as regulating internal policies and procedures for companies and work organization regulations, as well as preparing forms that assist the Human Resources Department in managing and hiring employees, addressing problems related to the Human Resources Department in companies in accordance with the Labor Law and Social Insurance, and providing all Consulting related to Madad Platform.

Wathyq also provides companies' transformation, merger, and voluntary liquidation services, as well as amending articles of incorporation, preparing partners' decisions to amend articles of incorporation, preparing and drafting the minutes of the general assemblies of shareholders in joint-stock companies, and submitting them to the Ministry of Commerce, and carrying out all the necessary legal procedures to amend the articles of association of companies in accordance with the Companies Law. Wathyq, in cooperation with the financial advisor for joint-stock companies wishing to enter the parallel market and the main market "Tadawul", is working

on preparing all the requirements of the Capital Market Authority in its capacity as a legal advisor, including but not limited to: preparing due diligence reports, prospectus, and governance regulations required for registration in the capital market authority.



Contracts

Franchise contracts:

Franchise contract is a licensing contract to make use of a renowned commercial trademark, which can be used by a person who wants to open a branch for such activity according to conditions set by the licensor. Our Firm undertakes drafting and reviewing such contracts and documenting them with the relevant authorities in order to achieve legal protection for both parties to the contract

Electronic Commerce (e-commerce) Contracts:

Electronic commerce: an activity of economic character conducted by the service provider and the consumer partially, entirely or through electronic means for the sale of products, provision of services, advertisement of the same or exchange of relevant data. Therefore, we provide all legal consultations and legal protection needed for the parties of such modern trade.





Bankruptcy:

Our firm Wathyq submits bankruptcy applications from the debtor or the creditor, in all its divisions, namely:

Protective Settlement: A procedure aimed at facilitating the debtor's reaching an agreement with its creditors to settle its debts, in which the debtor retains the management of its activity.

Financial Restructuring: A procedure aimed at facilitating the debtor's reaching an agreement with its creditors on the financial restructuring procedures of its activity under the supervision of the Financial Reorganization Trustee.

Liquidation: A procedure aimed at counting the creditors' claims, selling the bankruptcy assets, and distributing its proceeds to the creditors under the management of the liquidation trustee.

Protective Settlement for Small Debtors: A procedure aimed at enabling the small debtor to reach an agreement with its creditors to settle its debts within a reasonable period through easy procedures at low cost and high efficiency, while the debtor retains the management of its activity.

Small Debtors' Financial Restructuring: A procedure aimed at facilitating the small debtor's reaching an agreement with its creditors for easily financial restructuring procedure of its activity within a reasonable period at low cost and high efficiency, under the supervision of the trustee.

Small Debtors Liquidation: A procedure aimed at selling the assets of the bankruptcy and distributing its proceeds to the creditors within a reasonable period through simple procedures at low cost and high efficiency, under the management of the trustee.

Administrative Liquidation: A procedure aimed at selling bankruptcy assets whose sale is not expected to result in proceeds sufficient to meet the expenses of the liquidation procedure or the Small Debtors Liquidation Procedure under the management of the Bankruptcy Commission.

Watheq will follow up on the above requests, attend the necessary judicial sessions, and plead within all the legal procedures specified by the Bankruptcy Law and its executive regulations and all documents related to bankruptcy.
